# USAMA Grand Nationals Information!



## Competitor Equipment/Attire:

**Mandatory Forms & Weapons Attire:** Must wear uniform which is **traditional** with respect to his/her style.

**Mandatory Sparring Equipment & Attire:** Martial arts uniform (No T-Shirts or Sleeveless uniforms), Soft dipped Foam or USNKF (or similar) Headgear & Handgear, & Footgear, Mouthpiece (Double mouthpiece for those with braces), & Groin Protection (All males).

**Mandatory Koshiki Gear:** Martial arts uniform (No T-Shirts or Sleeveless uniforms), Mouthpiece, & Groin protection (All males); Shin Pads recommended. Headgear and Chest Protector will be provided at ring.

**Mandatory TDS Equipment:** Mouthpiece, Open Hand padded gloves, Shin Guards, & Caged Head Gear (A few Head Gear will be on hand to borrow, if needed.) Uniform, or mid-thigh shorts or longer, MMA shorts, or yoga pant; and Rash Guard or T-shirt. Women must also wear sport bra. Men must wear groin protection.

**Prohibited items in Sparring, Chanbara, Koshiki, or Take Down Sparring:** For the safety of our competitors, **No** regular eye glasses (**safety glasses only**), **No** metal or hard plastic joint braces, plaster or fiberglass casts will be allowed. Medical devices must be approved by our medical personnel and Chief Referee.

**Disqualification:** A competitor may be disqualified for excessive contact, illegal techniques, & unsportsmanlike conduct and will not be entitled to a refund or allowed to fight in any further events that day. Coaches' and Spectators' unsportsmanlike conduct may also be cause for a competitor's disqualification.

## Judges & Officials Attire for Tournament:

**Judges and officials,** please wear either your traditional martial arts uniform, or dress pants/skirt with white shirt and blue sports jacket during the competition. We appreciate your **professionalism**.

## Grand Champion Competition at Finals on Sunday evening at 7:00 pm:

**Black Belt Weapons, Adult Kyu Weapons & Kata, Youth Weapons, and Beginning, Intermediate, & Advanced Youth Kata Divisions:** All First Place Kata and Weapons winners qualify to compete for their respective Grand Champion honors at the Finals.

**Black Belt Kata:** All First Place Adult Black Belt Kata winners qualify to compete for Black Belt Kata Grand Champion honors at the Finals. The Adult Black Belt Kata Grand Champion competitors will perform three different katas to determine the winner.

**Black Belt Men Sparring & Black Belt Women Sparring:** All First Place Adult Black Belt Sparring winners qualify to compete for their respective Grand Champion honors at the Finals.
